# Pathways Community HUB Model: Building a Network of Care Coordination for Those at Risk and Paying for Performance

#### Description:

What's a HUB - A Pathways Community HUB is a lean infrastructure that provides tools and strategies needed to ensure that at-risk individuals are served in a timely, coordinated manner. The HUB ensures that a person and populations receive meaningful and coordinated health and social services that produce positive outcomes and control costs. Further, HUBs help avoid duplication of services and keep people from falling through the cracks. A Community HUB and its accompanying Pathways represent effective vehicles for achieving greater financial accountability for the delivery of high-value health and social services, and improving health outcomes.
